## UPGRADE OF THE FLINDERS DRIVE PEDESTRIAN CROSSING WITH FLASHING TWIN LIGHTS

### NOT COMMENCED

- Flinders Medical Centre is being upgraded



## Parking Requests (Illegal or Unsafe)






Capital Works Projects reflect the number projects underway during the 2023/2024 financial year, capturing progress on active projects and highlighting completed projects implemented in the community.

- Bus Shelter at Stop 25 Main Road was partially completed in Q2 2023/24.




- Dorene Street carpark at St Mary's Park has been completed.

# **INNOVATIONS**

### **Community Capacity Building - Health & Wellbeing**

Community Wellbeing promoted SA Ambulance Service's new Clinical Telephone Assessment service to existing clients. This is an over the phone, free assessment by a paramedic health technician to obtain reassurance or advice on the best care pathway when clients feel worried that they are 'not unwell enough' for an ambulance. Additionally, magnetic emergency medical information booklets produced in partnership with Lions and Rotary are posted with all new client welcome letters. The booklets are filled out by clients with medical history and medication information, stored on the refrigerator, and are recognisable to paramedics in attendance.

## First Club Workshop

Held at the Council Civic Centre on Wednesday November 29. The topics covered in the workshop, as guided by feedback from our Information Session in August, were Work Health and Safety, Risk and Inclusion. The Work, Health and Safety and Risk portion focused on the obligations of clubs to their members and employees, and risk assumption. The Inclusion section of the session was facilitated by an external group, Active Inclusion and was a starting point to changing mindsets and building inclusion culture within sporting organisations.

# **FOCUS INSIGHT**

### 144

Vaccines administered at Community clinics

Since Quarter 1 2023/24, Council has experienced a **88.75**% **decrease** in the number of vaccines administered at Community Clinics with only **144 vaccines administered** in Quarter 2.

- Council typically delivers less vaccines during Quarter 2, the decrease in the number of vaccines administered this quarter is primarily attributed to timing.
- There were no school clinics during the months of October, November and December as Council completed the school program in September 2023 during Quarter 1.



Volunteers at the City of Mitcham

- In Quarter 1, Council reported an innovation of the Volunteer inductions becoming an online process through the utilisation of Velpic.
- Since the implementation of online inductions, Council has seen an increase in the number of volunteers at the City of Mitcham by 2.27% in Quarter 2. While this appears as a small increase, the new process has been well received and actively contributes to Council's green vision.
- Many of the new Volunteers are in the Open Space program. Council also inducted new Volunteers for the Pasadena Community Centre, which is steadily gaining momentum.
- Council have also created new mechanisms within the recruitment tab in TechOne, allowing the Volunteer Coordinator to register potential Volunteers online, streamlining the process and reduce paper usage.




Capital Works Projects reflect the number projects underway during the 2023/2024 financial year, capturing progress on active projects and highlighting completed projects implemented in the community.

Property Capital Works - Renewal



- Council's renewal program is progressing steadily with design work complete for majority of projects and tenders underway.
- A couple of projects have been put on hold/being designed for delivery in the next financial year pending the outcome of project scoping.

### Property Capital Works - New



- Council have had significant progress on a number of projects with the Sod turning at Eden Hills Scouts taking place in December and site works progressing.
- Final staff consultation for the office refit has been completed with positive feedback.
- Design for the new Public Toilets at Manson Oval have been presented and community consultation scheduled for February.
- Contract for Hawthorn Bowling Club entrance work has been finalised with site works scheduled to begin in March.
- Tiwu Kumangka is still in the Defects Liability Period. Council are working through minor defects with the building contractor. All major defects have been attended to and temporary fencing completely removed from Waite Reserve, with positive feedback from the community.
- A number of projects remain on hold awaiting outcomes of grant applications and consultations.



### **Sustainable Living Subsidy Program**

This project is planned to be launched starting 1 February where residents will be able to submit an application to Council to receive a rebate for certain reusable sanitary products. In preparing the CRMs and payback system for the rebate, the Sustainability Team worked closely with Finance and IT to allow the CRM form to receive payment details safely and securely from residents, without the need for paper forms. This will enable other payee systems, such as our Grant programs, to be done via our CiA system rather than submitting manually and in hard copy form.



# INNOVATION

### **Dog Holding Facility**

The Community Safety Team wishes to highlight a business improvement initiative from December 2023, involving a partnership with the City of Burnside to utilise their Dog Holding Facility. Despite the City of Mitcham's high success rate for reuniting dogs with owners on the same day as impound, its daytime holding cages are not fit for purpose for overnight use. Annually, on average the City of Mitcham impounds 60 dogs a year with approximately 12 proceeding to a suitable overnight holding facility.

Before the collaboration with City of Burnside, the animal holding service provided by the RSPCA at Lonsdale was \$1500 for a 72 hour period. Additional to a recent service fee increase it is understood the facility is often at capacity, which resulted in officers having to commute to other facilities such as the Animal Welfare League (located at Edinburgh North) resulting in additional travel time to and from each facility.

The City of Burnside purpose-built dog holding facility at Conygnham Street Glenside offers several benefits, including;

- A significant cost saving to Council, noting a 72 hour holding period for an animal at Burnside's Facility is \$270.
- Logistically friendly location noting the facility is located approximately 10 minutes from the Mitcham's Civic Centre.
- Readily available access, noting the facility remains open for access to animals until 8PM each weeknight and 6PM weekends/ public holidays.
- Support to a neighbouring Council and promotion of shared services.
- Quicker recovery and re-uniting animal with owner.

The facility has been used once to date, it is understood the transition has been seamless and cost savings noticeable.

### **Serious Incident Response System Compliance Collaboration**

Commonwealth Home Support Program (CHSP) funded organisations have a responsibility to have a Quality & Safeguards Commission compliant Serious Incident Response System (SIRS) in place. After building a SIRS for Mitcham, Community Wellbeing collaborated with the City of Onkaparinga and the Southern Services Reform Group to participate in a tailored 'Train the Trainer' workshop for two Community Wellbeing staff, building capability in the team and providing an avenue to train staff and volunteers without requiring external contractors.

### **Light Vegetation Crew Pilot Program**

The City of Mitcham Depot initiated a pioneering collaboration with Urrbrae Agricultural College, launching a pilot program known as the Light Vegetation Crew. The main aim of this initiative was to generate part-time job prospects for horticultural students during school breaks, concurrently supporting the City of Mitcham's workforce in addressing pending light vegetation tasks.

Enlisted students were hired as casual workers, forming a compact crew entrusted with various responsibilities including mulching, garden bed planting, leaf blowing, creek clearing, and tree planting. The pilot proved to be a success, accomplishing its objectives by providing employment opportunities and creating a positive learning environment for horticultural students. Feedback from participants highlighted their enjoyment and educational gains from the experience.

The City of Mitcham looks forward to building upon this success in the future, fostering an enduring partnership with Urrbrae Agricultural College and expanding the program to offer more students valuable opportunities in the field.

The assessment of application is a more concise process that better reflects the intent of the Act. The role of the staff member who assists in the review and that of the Reviewer is clearer. Templates for reporting of the assessment and the report to assist the Reviewer have been developed and will continue to be improved. A review of the City of Mitcham Independent Review of a Decision Policy and Procedure is underway to ensure that our practice reflects the procedure.




### **Virtual Reality Proof-of-Concept (POC)**




# **FOCUS INSIGHT**
