

Why Review?

- Legislative requirement (within two years of election).
- Opportunity to align vision and priorities to new Council Member body and consider new organisational foci.
- Set an external vision to meet community expectations.
- Identify Priority Themes & Investments for the next four years.

Minimum Review Requirements (s122)

- Define objectives and principal activities required to deliver economic, social, physical and environmental outcomes.
- Set measures to monitor and assess performance.
- Identify alignment with other councils, state and national governments and their plans.
- Seek input from the community.
- Align output with ABP & LTFP.

Update Mitcham 2030 and Priority Themes

Draft Project Objectives

- 1. Keep the review simple.
- 2. Maintain high-level goals/themes, set priority themes via a Four Year Delivery Plan, set actions through the Four Year Delivery Plan and Annual Business Plan.
- 3. Only change what's necessary to reflect new elected body direction or fundamental shift in community focus.
- 4. Mitcham 2030 (**the document**) is not intended as a tool for organisational transformation.
- 5. Mitcham 2030 (**the process**) is capitalised to elevate strategic thinking.

Statutory Review Learnings, so far...

Alignment to regional, state and national plans

- Well aligned and not at odds with strategic aspirations of other governments
- Opportunity to strengthen alignment with some state and national objectives.
- For example, housing affordability, renewables, reconciliation, etc.

Statutory Review Learnings so far

Demographics

- No significant demographic changes captured by 2021 census
- Key insights include a slowing rising median age, high household income, declining volunteering.

Statutory Review Learnings so far

Performance against existing SMPs

- Community surveys undertaken in Nov/Dec 2020 and Oct 2021
- Benefit from going out again soon...
- Utilised the 34 Community Insights to track Council's progress towards achieving its vision.
- Findings showed some areas for extra effort including ease of travel, response to climate, more attention to businesses, Council innovation.
- These insights from the last few years helped to inform the shape and priority of funding requests.

Statutory Review Learnings so far

Challenges & Opportunities

- Housing / homelessness
- Ageing populations, disability pressures and low fertility
- Cost of living & supporting local business
- Anti-trust in government and media
- Connection deficits / isolation
- AI & Technology disruption
- Defence & threat of war
