## 1. IDENTIFICATION DETAILS

Drainage Reserves which are the subjects of this Community Land Management Plan (CLMP) are located at various sites within the City of Mitcham (Council). They contain underground stormwater piping or are located where natural overland water flow occurs to direct stormwater into the larger drainage system. Drainage Reserves may (where accessible) be used by the community to connect to the road or footpath network. This CLMP applies to the following pieces of land.

## 2. PURPOSE FOR WHICH THE LAND IS HELD

The Land is held by the Council to facilitate stormwater being discharged into the drainage system.

## 3. REASON WHY MANAGEMENT PLAN IS REQUIRED

- Portion of the Land is, or is to be, occupied under a lease or licence.
- Portion of the Land has been, or is to be, specifically modified or adapted for the benefit or enjoyment of the community.

## 4. OBJECTIVES FOR THE MANAGEMENT OF LAND

The objectives for the management of the Land are set out below and replicated in Schedule 1 of this CLMP which also includes the performance targets and measures.

- To provide stormwater management including through infrastructure, to allow stormwater to be effectively and safely directed and discharged into the drainage system.
- To permit where not inconsistent with the Council's other stated objective occupation by adjoining residents where there has been an established occupation.

- There is an upgrade of the existing infrastructure assets in line with Council's asset renewal program to allow for the continued use for drainage and stormwater disposal.
- There is the installation of artworks commissioned under the Public Art Grants program in a manner not inconsistent with the purpose or objectives for the use of the land.
- Public access to some parts of the Land is restricted where required for community safety.

- To enable the occupation of part of the Land by adjoining residents where a proven and established long term use can be determined.
- To allow for the provision of essential infrastructure related to electricity, gas, water, internet and telecommunications services.

The granting of permits for one or more of the following purposes (in no particular order) is consistent with this CLMP and is authorised for the purposes of section 202(3) of the *Local Government Act, 1999*:
