#### 1. PREAMBLE

The flying of flags is a very visible and recognisable symbol of country, state, corporate or cultural identity. Great importance is placed on the dignity of the flag, its appearance and how it is treated.

#### 2. PURPOSE

This Policy provides guidance for the flying of flags on Council-owned flagpoles (or under Council's care and control) in accordance with the Spirit of the Australian National Flag protocols.

#### 3. SCOPE

The Policy applies to flagpoles listed in Section 1 of Attachment A.

Flagpoles listed at Section 2 of Attachment A are not covered by this policy (except where explicitly specified giving effect to a council resolution).

# 4. PRINCIPLES

Flag flying protocols are outlined in the booklet *Australian flags – Part 2: The protocols for the appropriate use and the flying of flags* which can be found <a href="https://www.itsanhonour.gov.au/symbols/docs/australian\_flags\_excerpt.pdf">https://www.itsanhonour.gov.au/symbols/docs/australian\_flags\_excerpt.pdf</a>

In particular the following protocols are noted for the Australian flag and other flags:

- 4.1 The Australian flag takes precedence over all other flags with the exception of the United Nations flag on United Nations Day.
- 4.2 When flown with other flags, the Australian flag should be raised first and lowered last unless all flags are raised and lowered simultaneously.
- 4.3 The rule of precedence should be followed when there is more than one flagpole. The Australian flag should always be flown on the far left hand flagpole as seen when facing a building (the pre-eminent position), with order of precedence of other flags to follow the Australian National Flag Protocol.
- 4.4 The Australian flag can only be flown at night when appropriately illuminated. Otherwise it should be raised no earlier than first light and should be lowered no later than dusk.
- 4.5 The dignity of the flag should be preserved at all times. It must not be flown if damaged, faded or dilapidated and must not be allowed to fall or lie on the ground.
- 4.6 The Australian flag will be flown at half-mast as a sign of mourning, as dictated by the Australian and/or the State government, observing all flag protocols.

### 5. POLICY STATEMENT

The significance of flying the Australian flag and other flags is acknowledged in the following ways:

5.1 The Australian flag will be flown 24 hours a day where a Council flagpole is illuminated.

- 5.2 Where there is only one permanent flagpole, the Australian flag will be the only flag flown on that flagpole.
- 5.3 If a flagpole is not illuminated, it will be for ceremonial use only. For example, the Australian flag will be raised and lowered for Anzac ceremonies.
- Where there are two illuminated flagpoles the Australian flag will be flown in the pre-eminent position and the City of Mitcham flag to its right (when looking at the flagpoles).
- 5.5 Where there are three illuminated flagpoles the Australian flag, the Aboriginal flag and the City of Mitcham flag will be flown.
- 5.6 If a decision has been made to fly another flag for a particular occasion, it will take the place of the City of Mitcham flag.
- 5.7 Flags displayed in the Council Chambers be displayed vertically with the Australian Flag, Aboriginal Flag, Torres Strait Islander and City of Mitcham Flags being on display at all times.
- 5.8 At the Blackwood War Memorial, two of the five flag poles will accommodate the Australian Flag and Aboriginal Flag. The other three poles will fly flags of the RSL's choosing in the spirit of the Australian National Flag Flying Protocols.
- 5.9 At the Blackwood War Memorial, the Torres Strait Islander Flag will replace one of the flags of the RSL's choosing (at clause 5.8 above) to commemorate NAIDOC week, Sorry Day and Reconciliation Week and on other occasions through consultation between the Blackwood Reconciliation Group and the Blackwood RSL.
- 5.10 The Blackwood RSL will be responsible for the lowering and raising of all flags on the five flag poles as required to comply with the clauses 5.8 and 5.9 above.

#### 6. DESIGNATED FLAGS

- 6.1 The following designated flags will be flown in place of the City of Mitcham Flag on the following occasions:
  - Day against homophobia, transphobia and biphobia (17 May) Progress Pride Flag
  - The month of November (including the Feast Festival) Progress Pride Flag
- 6.2 On the following days, the Australian Flag will be flown as follows;
  - ANZAC Day (25 April) Flags are flown at half mast until noon.

- Remembrance Day (11 November) Flags are flown from their peek from 8am and half mast from 10:30-11:02am and at the peak again.
- 6.3 Applications to fly flags other than those identified herein must be made in writing to the Chief Executive Officer and received at least eight (8) weeks prior to the requested date.
- 6.4 Written applications must address the following:
  - demonstrated local, state and/or national significance;
  - demonstrated social, cultural, environmental, economic, political and/or historical significance;
  - demonstrated support in the community for the cause.
- 6.5 All applications to fly flags other than those identified in 6.1 will be determined by Council resolution.
- 6.6 Approving an application will not create a precedence which cannot be sustained.
- 6.7 Flags will not be flown in hazardous weather conditions.
- Requests to fly flags on flag poles under the care and control of a third party will be dealt with by said third party.

# 7. POLICY REVIEW

This Policy will be subject to review every four (4) years or sooner at the discretion of the relevant General Manager.

The CEO has delegated authority to endorse any amendments to the Policy that do not vary the intent of the policy.
